CONDITIONS OF OCCUPANCY

Please Read Carefully

1. The booking is made in good faith by us. However, we can not be held responsible for actions outside our control, and we reserve the right to cancel any booking should anything arise, which in our opinion renders the booking impractical. In either event we will contact you as soon as possible and do our best to arrange alternative accommodation or dates suitable to you, failing which all deposit monies paid will be refunded, but no other claim, right or action or demand shall exist in or be made by either party.
2. Deposits –Bookings 50% of total tariff before 14 days of occupancy, if less than 14 days total tariff to be paid.
3. All fees are to be paid by direct deposit or cheque made out to Guthega Ski Club.
4. Cancellations – No refund if cancelled after final payment. Cancellation prior to this will attract a cancellation fee of 20% of deposit
5. Door code will be given to you on payment of final payment.
6. Occupancy of your room is given after the previous occupant has left it in a clean state. Your room is to be vacated in a clean state on date of departure
7. The number of occupants **including children** must not exceed the number stated at the time of booking. Overcrowding of the premises will not be allowed by the National Park or committee.
8. **NO PET ANIMALS OR BIRDS ARE PERMITTED IN THE PARK UNDER ANY CIRCUMSTANCES.**
9. Any printed, written or verbal description of the premises is made in good faith, however no responsibility for mis-description can be accepted.
10. As the occupant you are responsible for damages, breakages and loss incurred during the term of your occupancy. All damage, breakages or losses are to be reported to the party leader immediately.
11. The premises are to be left in a reasonable, clean & tidy condition. Please put all garbage in the bins provided & remove you left over food from the fridge and kitchen cupboards prior to departure.
12. A duty roster will be posted on the notice board with a duty assigned to you. Please complete this prior to leaving.
13. Weekend bookings are for Friday and Saturday nights, except under certain circumstances at the discretion of the committee.
14. Parking is available in the lower unsealed car park below the chair lift building on a first come basis. Please park responsible. When this is full there is further space available a few hundred metres further down the road. Parking in the mountains is a privilege so please don't abuse it. You may be required to shift your car for snow clearing.

It is a condition of the provision of accommodation by this Club that the member/guest to whom accommodation is provided by this club is responsible for the safety of all valuables, equipment and clothing of the member/guest or of any guest of the member, and the member/guest releases this Club from all liability for loss or damage to any such valuables, equipment and clothing however caused and agrees to indemnify this Club against any claim which might be made against it for loss or damage to such valuables, equipment and clothing by the member/guest or any guest of the member.
