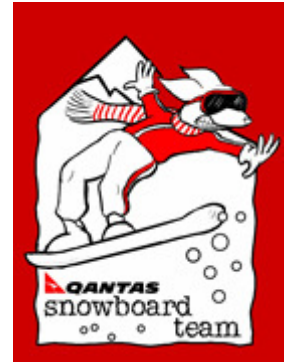




## MEMBERSHIP APPLICATION FORM

2. Associate membership is open to any person who is not an employee of Qantas Airways Ltd. and Qantas Subsidiary Companies.
3. Annual subscription is only available to applicants who are employees of a Qantas Subsidiary Company (e.g. QantasLink, Jetstar, Qantas Defence Services), retirees and non-Qantas Airways applicants.
4. Qantas employees must complete Authority for Salary Deduction.
5. Non-Qantas Airways Ltd. applicants must be introduced by a current member. Associate Membership is subject to approval by the Qantas Ski Club Committee.
6. Membership Subscription for current Qantas staff is \$0.40 per week by salary deduction only; or \$26 per year for current Qantas Subsidiary Companies staff, and retirees of Qantas Airways Ltd. and Qantas Subsidiary Companies as salary deduction is not available. Associate Membership Subscription is \$26 per year.
